

Dear Parade Participants:

It is a pleasure to invite you to participate in the 2009 Magnolia Kids and SummerFest Parade. The parade date is Saturday, August 1, 2009. The parade begins with a kids parade scheduled at 10:30 am, and is followed by the Main Parade, with marching bands, marching units, comic units, wheeled units, mounted units, and floats. Last year we had over 500 children and about 75 units of all kinds participate.

Parade line up begins one block north of 34th West and West Raye. The parade runs south on 34th Avenue West, (at West Raye), turns east on West McGraw Street, and turns north on 32nd Avenue West, with dispersal after West Raye. The parade will not take more than 15 minutes to complete once marching begins.

The assembly for the Kids Parade will be West Raye Street between 34th and 35th Avenue West which is accessed via 34th Avenue West. Dispersal will be in the NE parking lot of Catherine Blain Elementary School which is accessed via 32nd Avenue West.

Enclosed is an application packet. We are required by the City of Seattle and The Magnolia Chamber to have each individual participant sign a hold harmless agreement. Please make copies for every individual in your group. Either return all of the hold harmless forms with the application in the mail or bring them to the parade on parade day. Also, if you are a motorized unit we require a copy of your proof of insurance certificate be included with your application. If a commercial entry we need proof of liability insurance.

While there is no entry fee we will accept donations to offset parade expenses. For donations of \$50 or more you will be included as a sponsor in the festival program.

If you would like more information or have any questions please don't hesitate to call. We sincerely hope that you will be able to include our parade in your plans for your 2009 season.
