

Dear Parade Participant

It is a pleasure to invite you to participate in the **2011 Magnolia Kids and Summerfest Parade**. The parade date is July 30, 2011. The parade begins with a kids parade scheduled at 10:30am and is followed by the main parade and marching bands, drill teams, floats and more! Last year we had over 500 children and about 75 entries of all kinds participate.

Parade line-up begins one block North of West Raye Street on 34<sup>th</sup> Avenue West. The parade runs South on 34<sup>th</sup> Avenue West, turns East on West McGraw Street and turns North on 32<sup>nd</sup> Avenue West, with dispersal after West Raye Street. The kids parade will not take more than 15 minutes to complete once marching begins.

The assembly for the Kids Parade will be on West Raye Street between 34<sup>th</sup> and 35<sup>th</sup> Avenue West which is accessed via 34<sup>th</sup> Ave West. Dispersal will be in the NE parking lot of Catherine Blaine Elementary School which is accessed via 32<sup>nd</sup> Avenue West.

Enclosed is an application packet. We are required by the city of Seattle and the Magnolia Chamber of Commerce to have each individual Participant sign a Hold Harmless Agreement. Please make copies for every individual in your group. Either return all of the hold harmless forms with the application or bring them to the parade on parade day. Also, if you are in a motorized unit we require a copy of your proof of insurance certificate be included with your application. If a commercial entry we need proof of liability insurance.

While there is no entry fee, we accept donations to offset parade expenses. For donations of \$50 or more you will be included as a sponsor in the festival program.

If you would like more information or have any questions please don't hesitate to call. We sincerely hope that you will be able to include our parade in your plans for your 2011 season.

No one will be allowed to participate without this form being submitted prior to the start of the parade.
