The annual Magnolia Summer Festival for 2008, an official Seafair event, is seeking Art vendors with original quality art products. Festival activities include live music, children's entertainment, art, crafts, and food booths, and the annual Magnolia Seafair parade, the largest children's parade in the state. 5,000 people attend the Festival.

Dates & Times	Friday, August 1st , 11:00 am to 7:00 pm • Saturday, August 2nd , 10:00 am to 6:00 pm
Location	Magnolia Playfield (Corner of 32nd Avenue West & West Smith)
Registration	Registration must be received by Friday, May 2nd . <i>*Acceptance notification by Friday, May 30th</i> .
Application Fee	Fee of \$100 is enclosed _____. Make check payable to: Magnolia Chamber of Commerce.
City License	Vendor shall have a City of Seattle Business License or pay \$5.00 per day (\$10.00 total) license fee. Vendor is responsible to pay all state and/or city taxes resulting from his/her festival sales.
Setup	Thursday, July 31 st between 4 – 8 pm and Friday, August 1 st before 11am
Booth Size	10' X 10'. Only the space is provided and festival designees will determine location. Vendor must provide a 10'x10' tent, tables and all set-up materials.
Care	The Magnolia Chamber of Commerce, or anyone acting on its behalf, assumes no responsibility for loss or damage to your belongings. A security guard will be on site Thursday & Friday nights. It is recommended that vendors carry liability insurance.
Photos	Vendors must submit at least 3 photos of art that will be sold. Mail or e-mail the photos. If you wish the photos to be returned please include a self-addressed stamped envelope.
