<b>City License</b>	<b>Vendor shall have a City of Seattle Business License or pay \$5.00 per day (\$10.00 total) license fee.</b> Vendor is responsible to pay all state and/or city taxes resulting from his/her festival sales.
<b>Setup</b>	Thursday, July 30 <sup>th</sup> between 4 – 8 pm and Friday, July 31 <sup>st</sup> before 11 am
<b>Booth Size</b>	10' X 10'. <b>Only the space is provided and festival designees will determine location.</b> <b>Vendor must provide a 10'x10' tent, tables and all set-up materials.</b>
<b>Care</b>	The Magnolia Chamber of Commerce, or anyone acting on its behalf, assumes no responsibility for loss or damage to your belongings. A security guard will be on site Thursday & Friday nights. It is recommended that vendors carry liability insurance.
<b>Photos</b>	Vendors must submit at least 3 photos of art that will be sold. Mail or e-mail the photos. If you wish the photos to be returned please include a self-addressed stamped envelope.
