

MAGNOLIA SUMMER FESTIVAL ● FOOD BOOTH APPLICATION INFORMATION

AT MAGNOLIA PLAYFIELD ON WEST SMITH STREET

The annual Magnolia Summer Festival for 2006 will be held at Magnolia Playfield on West Smith St. The festival is an official Seafair event scheduled during Seafair, August 4 and 5, 2006 (Friday and Saturday). Activities include Children's entertainment, craft booths, food booths, and beer garden. On Saturday morning (10:30 am) the largest kiddies parade in the state and the annual Magnolia Seafair parade will be held.

Summer Festival is seeking approximately 7 food vendors serving quality food products. This fair, while not being among the largest, does offer a clientele interested in quality and originality. Those wishing to participate must return their application with fee no later than May 1 to retain their early status.

Cost: \$350.00. 10'x10' space. Larger space will be additional

Required: City of Seattle Business License. If you do not have a license to do business in Seattle a fee of \$5.00 per day will be charged (\$10.00).

Fire Permit for use of liquid petroleum gas and open fire (wood, charcoal). Contact the Seattle Fire Department at (206) 386-1450

Application: Vendors must submit 1 photo of food and 1 photo/drawing of your booth. Please identify each photo and they will be returned during the festival.

Booth Size: 10' x 10'. We provide only the space. We do provide a security guard Thursday and Friday night. The Chamber of Commerce and Summer Festival assumes no liability for any vendor property. Locations will be assigned as applications are received and accepted.

Requirements: 100 feet of electrical cord (3 prong) if electricity needed.
Adequate signage indicating prices for all items.

The annual Magnolia Summer Festival will be held August 4 and 5, 2006 at the Magnolia Field at West Smith St. **Please note the following must be provided by each food vendor.**

1. A current permit issued by the Seattle Department of Public Health.
2. Seattle Fire Department fire permit.
2. If power needed, 100 feet of electrical cord – 3 prong.
3. Adequate signage indicating prices for all items.
4. City of Seattle Business License Number. If you do not have a Business License a \$5.00 per day fee will be charged (\$10.00).

COST: \$350.00 for 10'x10' space rental. If more than 10'x10' space is required, additional fees will be charged. Food Vendor will be responsible for paying appropriate state and city taxes. A security guard will be on the premises at night, yet we cannot guarantee security.

The exhibitor agrees to defend, indemnify and hold harmless the Sponsor (Magnolia Chamber of Commerce), from and against any and all claims, demands or expenses (including attorney's fees) for libel, slander, invasion of privacy, infringement of copyright or personal injury or damages or any other claims, demand or expenses resulting from the exhibitor's performance in connection with this agreement.

**MAGNOLIA SUMMER FESTIVAL
Food Booth Agreement**

Magnolia Chamber of Commerce, hereinafter known as MCofC, and _____, hereinafter known as Vendor, in consideration of their mutual promises set forth herein below, do hereby agree as follows:

1. Vendor shall be permitted to operate a food booth during the Magnolia Summer Festival, August 4 - 5, 2006 at an area at the location of the festival to be designated by MCofC, the said permission representing a valuable benefit to Vendor. This permission is subject to MCofC's right of refusal.
2. Vendor shall pay to MCofC at the time of submission of this Application/Agreement:
Food Booth: \$350.00 (____) enclosed. Fee of \$10 () in lieu of Seattle business license.
3. Vendor shall comply with all applicable laws and regulations in connection with the operation of Vendor's business at the Magnolia Summer Festival, including payment of all state and city taxes due from said operation.
4. Vendor shall have a City of Seattle Business License or pay a \$5.00 per day license fee (\$10.00)
5. Vendor shall hold MCofC harmless as to any loss occasioned by anyone due to Vendor's said operation.
6. Vendor should carry liability insurance for their operation.
7. Each food booth application is to be accompanied by one (1) color photo showing representative products and a photo/drawing indicating the appearance of the booth. These photos will be returned upon request after the festival.
8. Vendor's food vending operation is described as follows:

Vendor shall execute and complete and deliver this Application/Agreement to MCofC at the address for MCofC no later than May 1, 2006 for it to be valid and binding upon MCofC. In the event that MCofC refuses this Application/Agreement, or if it is withdrawn prior to the Festival, the payment made by Vendor with this Application/Agreement shall be refunded.
